2. No relief shall be afforded to:			
(a) Any person who enters Grenada after an absence therefrom of less than			
twenty-four (24) hours or			
(b) Any person under the age of eighteen (18) years in respect of spirits (other than			
perfumed spirits), tobacco goods or wine.			
3. No relief shall be granted if the articles are brought in to be used for any commercial			
purposes.

whether remaining in Grenada, or for subsequent re-export.
